## HEROIN/OPIOID EUROPEAN MARKET

- Heroin grown in Afghanistan and transported via Balkan route
- 1.3 million high risk users in Europe
- Irish Prevalence in 2014/15 was 18,988 people
- Currently 11,461 people on Opioid Agonist Treatment (OAT)
- Opioids (mainly heroin) were the most common main problem drug reported in 2021. Heroin accounted for 87.3% (3,168) of all opioid cases in 2021. (NDTRS, 2022)
- Emergence of synthetic opioids across the EU is a concern, and two have been identified in Ireland in 2022





## DRUG MONITORING IN IRISH CONTEXT

- The volatile nature of the drug market is a healthcare concern as new and more potent substances continue to emerge on the European drug market.
- Presence of new psychoactive substances on the drug market and the re-emergence of cocaine injecting

#### Monitoring initiatives include:

- Syringe Analysis
- EMCDDA Monitoring European Web Survey Irish Findings
- Real Time Drug Checking Pilot test site in Electric Picnic 2022
- Waste Water collaborative project with UCD leading on the sample collection and analysis, report to be published by year end
- Hair Analysis will be further reviewed in 2023



## IRISH SYRINGE ANALYSIS PILOT PROJECT


- Report is evidence of the importance of cross-sectoral engagement to improve health outcomes.
- Part of the ESCAPE (European Syringe Collection and Analysis Project Enterprise) Network
- Successful collaboration between Merchants Quay Ireland, the HSE National Drug Treatment Centre laboratory, and the HSE National Social Inclusion Office.
- The findings from this study can now be used to inform interventions provided by MQI and other similar services.





## IRISH SYRINGE ANALYSIS PILOT PROJECT

- Regional differences were identified with niche trends found in both locations.
- Methamphetamine rates were higher in Dublin, with ketamine and Oxycodone also being unique trends in the Dublin region also.





- Pregabalin rates were higher in the Midlands Region but may be as a result of oral consumption.
- Fluarazepam is likely a result of the injection of this substance in this specific location.

## **REDUCING HARM AT FESTIVALS**

- As part of the HSE 'Safer Nightlife' harm reduction campaign, we are launching a pilot programme which will initially take place at Electric Picnic
- First Irish drug monitoring programme to analyse drugs to provide real time information at a festival setting, following recommendation of the Report of the Emerging Drug Trends and Drug Checking Working Group
- This pilot is being introduced so the HSE can gain knowledge on current drug market trends so they can improve harm reduction responses specific to nightlife settings.










## NALOXONE ADMINISTRATION REPORT

- This report has highlighted the fact that increased availability of training and the provision of naloxone in the community has potential to reduce drug- related deaths and continued investment will benefit individuals and their families.
- Over the three-year period, naloxone was administered on 569 occasions
- Estimated that this has resulted in saving at least 22 lives (using best available research)
