### **Current Policy**

# Naloxone Programme

A prescription medication used to temporarily reverse the effects of opioid drugs for example heroin, morphine, codeine, methadone and other opioids.



## 356 uses of naloxone reported in 2022

- 243 in Dublin, 68 in Cork, 14 Limerick, 11 in Waterford, 8 Kildare, 6 Kerry and 6 in the rest of Ireland
- 85% of uses were on men
- 48 people required CPR
- 51% of people went with the ambulance service

### 14 lives were saved in 2022







## 243 uses of naloxone reported in 2023

- 152 in Dublin, 39 in Cork, 18 in Limerick, 9 in Carlow, 7 in Louth, 5 in Kerry, 5 in Kildare and 8 in the rest of Ireland
- 405 doses of Prenoxad<sup>™</sup> and 125 doses of Nyxoid<sup>™</sup> administered
- 85% of uses were on men
- 49 people required CPR
- An Garda Síochána were present at 24 incidents
- 47% of people went with the ambulance service

### 9 lives saved in 2023 to date

### **Future Priorities**

- Progress will be continued by the further expansion of training and access to naloxone for those who may witness an opioid overdose including people use drugs, their peers, family members, staff and communities.
- Continue to support the process of enhancing access to naloxone, particularly for family members.
- Continued engagement with key stakeholders, such as An Garda Síochána, the Irish Prison Service and homeless service providers, regarding naloxone education, training and potential provision for frontline members.
- Commence the establishment of a peer to peer naloxone training programme facilitated nationally by our partner services.
